Dear Leader Schumer, Leader McConnell, Chair Murray, and Vice Chair Collins:

We write as Members representing disaster-impacted states to request additional disaster relief funding. Now that Congress has addressed urgent foreign aid funding needs, we believe it is time to turn to the nation's domestic disaster recovery requirements. The Administration first requested supplemental funding to help address disaster recovery last October, and now those resources are long overdue. Across all of our communities, the federal government has a role to play in supporting families to find housing and return to normalcy, small businesses in getting back to work, and state and local governments in providing resources and leadership that our constituents need.

Our states rely on many programs across the federal government to recover and rebuild from disasters. The needs listed below are urgent and many have been pressing for months. We must act to provide resources for the below programs—
