#### **3** SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Biennial Budgeting5 and Appropriations Act".

### 20 SEC. 10. EFFECTIVE DATE.

Except as provided in sections 7 and 9, this Act and the amendments made by this Act shall take effect on January 1, 2025, and shall apply to budget resolutions and appropriations for the biennium beginning with fiscal year 25 2026.
